**828.01 DEFINITIONS.**

As used in this chapter:

- (a) "Going out of business sale" means any sale, whether described by such name or by any other name, such as, but not limited to, "closing out sale," "liquidation sale," "lost our lease sale" or "forced to vacate sale," held in such a manner as to indicate a belief that upon disposal of the stock of goods on hand, the business will cease and discontinue at the premises where the sale is conducted.
- (b) "Goods" means all goods, wares, merchandise and other personal property, except choses in action and money.
- (c) "Person" includes an individual, firm, corporation, partnership, association or two or more persons having a joint or common interest.
- (d) "Removal sale" means any sale held in such a manner as to induce a belief that upon disposal of the stock of goods on hand, the business will cease and discontinue at the premises where the sale is conducted and thereafter will be moved to and occupy another location.

**828.02 LICENSE REQUIRED; FEE.**

(a) No person shall conduct a going out of business sale or a removal sale in the City without first obtaining a license therefor from the City Clerk as provided in M.C.L.A. 442.211 et seq.

(b) The fee for the license required by subsection (a) hereof shall be fifty dollars (\$50.00).

**828.03 COMPLIANCE WITH STATE LAW.**

No person shall conduct a going out of business sale or a removal sale in the City without complying with the provisions of M.C.L.A. 442.211 et seq. in every particular.

**828.99 PENALTY.**
